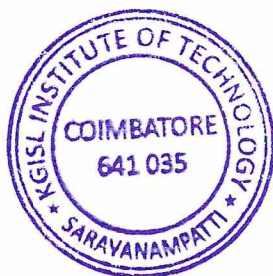

OPAC for library to include purchase and storage of resources (Books etc.) Issues and return.

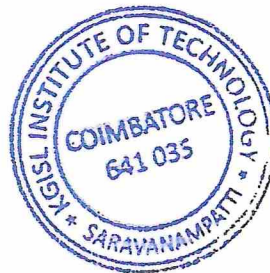
#### 6. Attendance
